In accordance with the permission granted by the Government of India, Ministry of Health & Family Welfare, New Delhi vide Lr.No. MCI-34(41)(E-52)/2019.Med/115522 Dt. 20.05.2019 and as per the Statues on affiliation of Medical Colleges of Kaloji Narayana Rao University of Health Sciences, Warangal, and as per the orders of the Vice-Chancellor, KNRUHS, Warangal, provisional affiliation is granted to *Mamata Academy of Medical Sciences, Bachupally, Hyderabad*, Telangana sponsored by Educational Society, # 5-7-200/8/A, MGH Campus, Khammam for starting 2nd year of existing MBBS Course and to make admissions into 1st year of MBBS Course with an intake of 150 (One Hundred and fifty) seats for the Academic Year 2020-21 as per the rules.

The number of students admitted should not exceed the number of students permitted for Annual Admissions both under University and Management Quota as specified by the State Government / Kaloji Narayana Rao University of Health Sciences, Warangal.

The fee collected by whatsoever name called either for university seats or for Management seats shall not exceed the limits specified by the State Government and Kaloji Narayana Rao University of Health Sciences, Warangal from time to time.

The Management of the college shall follow the regulations made by the University / State Government in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation in this regard may lead to withdrawal of affiliation to the college without any notice.
